## BYLAWS ARTICLE II: OBJECTIVES, SECTION 1. OBJECTIVES

The purposes and objectives of this Association shall be

- (a) To promote and project a positive image of private individual firearms ownership through the safe and responsible conduct of shooting on all ranges and through programs, courses, leagues, tournaments, and other activities, sanctioned and/or sponsored by this Association that would promote and project such a positive image.
- (b) The conservation of the natural resources of our Nation.
- (c) The sponsoring and support of legislation which furthers the purposes and objectives of this organization and opposing that which is adverse to those purposes and objectives.
- (d) To promote the impartial enforcement of game laws.
- (e) To encourage means to preserve or increase the supply of game fish by stocking, elimination of pollution and the application of modern, scientifically tested methods to the improvement of woods, land, and water areas of the state.
- (f) To engage in all types of social activities having any connection whatsoever with the maintenance and operation of the Association or which will financially or otherwise further these objectives.
- (g) To promote and encourage friendly relations between land owners, farmers, and sportsmen.
- (h) To encourage and influence, by personal conduct and joint effort, a public regard for game and fish protection and conservation.
- (i) To make contracts, buy, sell, and own property, and do everything necessary to carry on or accomplish the foregoing purposes.
- (j) To promote and preserve the continued viability of the association and its activities.

Please read carefully before signing the bottom of page 1 of this form

In return for being given permission to use firearms, enter into and use the AAF&G premises and facilities, and for other good and valuable consideration, I agree by my signature on the front of this form to the following: (a) to indemnify, hold harmless and defend the Anne Arundel Fish & Game Association, and any of its volunteers, employees, directors, officers or agents (the "AAF&G"), from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with: the discharge of firearms, the my participation in any course of instruction, or use of the AAF&G ranges, buildings, land and premises used for the course of instruction (the "Premises"); or my presence on or use of said Premises; and (b) should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of Maryland, the United States or of any State, or under any theory of law or equity, I will indemnify, hold harmless and defend AAF&G from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against AAF&G, whether individually or jointly, with me, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

I hereby expressly assume the risk of entering the Premises and of taking part in activities on the Premises which include, but are not limited to, instruction in the use of firearms and hunting equipment, the discharge of firearms, the firing of live ammunition, maintenance of club facilities and social activities.

I furthermore hereby acknowledge and agree that I have read, understand and shall abide by all AAF&G range rules and procedures, which may be amended from time to time. I also acknowledge and agree that AAF&G's Range Safety Officers will have broad authority to explain and enforce said range safety rules and procedures, and so agree to abide by and assist, when possible, the efforts of said AAF&G's Range Safety Officers to maintain adherence to said range safety rules and procedures.

I do hereby give permission to AAF&G to use any photographs, videos, or both, without attribution or compensation, which AAF&G took, for advertising, trade, and any other lawful purposes. I warrant that I have the full right and authority to grant this consent. I also waive any right to inspect or approve the finished photograph or video. I understand that this consent is perpetual, that I may not revoke it, and that it is binding on me, my heirs and assigns. I further attest that I have read this form and fully understand its contents.

I agree that this instrument, upon execution, shall bind me and my executors, administrators, assignees or heirs, and will be construed in accordance with the Maryland's laws. I hereby (i) consent to personal jurisdiction, (ii) agree to service of process by any reasonable means, and (iii) agree to Maryland Courts as proper venue.
