### RANGE RULE CHANGE

At the September Board of Directors meeting, a change in the range rules was approved and I wanted all RSOs and members to be aware of it.

This change applies to the High Power Range and is as follows:

Paragraph V(Range specific rules), F. (Hi Power Rifle Range), 1. (Shooting Positions) will read: SHOOTING OF LONGARMS MAY BE DONE FROM THE STANDING (OFFHAND), KNEELING, SITTING, AND PRONE POSITIONS ON THE CONCRETE PAD AS WELL AS SITTING AT THE SHOOTING BENCH.

*(The signs on the range will be changed to reflect this. The new rule will be incorporated in the 2009 Range Rules.)*

## RANGE RULES COMPLIANCE

There have been a couple of range rule violations reported to me recently and I wanted to take this opportunity to clarify and explain them to the general membership.

The members involved have been counseled by either an RSO on Saturday duty or by a letter from the Board of Directors and that is the extent of the formal action that will be taken in these particular cases.

I think however, that everyone needs to be aware of these two situations so that they do not make the same mistake themselves. Remember, SAFETY IS OUR NUMBER ONE CONCERN when shooting on our ranges!

The first incident involved a member shooting on the plinking range with his young son. No problem - we encourage all to teach their children about our great shooting sports; however, the problem in this case is that the member was shooting at the same time as his young son was, thereby severely restricting his ability to supervise his son's shooting and safety practices. **YOU CAN NOT SHOOT AND SUPERVISE AT THE SAME TIME!** This situation is addressed in our range rules under I. General Rules, Section O, which states that "Members are welcome to bring guests to the facility. Guests using the ranges must be under the direct supervision of a member. A member may not have more than two guests firing at any one time. A host cannot shoot and supervise at the same time."

The second incident, also involving the plinking range, occurred when a member had two guests shooting with him and then left them on their own, according to the guests, while he went up to the trap/skeet ranges with additional guests, and in the process, also left his

membership ID card with the plinking range guests!

When he did not return after some time, our duty RSO went up to the trap/skeet area looking for him and was unable to locate him there or elsewhere on our property! Subsequent investigation of this incident resulted when the member contacted our Board of Director's chairman in response to a letter sent to him about this incident. He acknowledged leaving the guests and card and stated that these actions were the result of his receiving a phone call from his wife with a serious family emergency requiring his presence at home immediately! (He apparently had not gone up the trap/skeet areas at all). Again, this

violation is covered by the above noted range rule with the additional infraction of his leaving his ID card (along with the gate entry code on the back) with non-members.

Fortunately in each of these incidents, no accidents occurred but all of us have to remember that it could take only ONE minor

infraction of our range rules for an accident to occur and the existence of our club seriously compromised. **WE ALL HAVE TO SHOOT SAFELY AND THINK SAFETY AT ALL TIMES.** Our range rules are there for this reason and **MUST BE FOLLOWED.** There is no excuse for lack of knowledge of these rules.

## BULLSEYE PISTOL REPORT

Anne Arundel Fish and Game did it again with representation for the second year in a row at the National Pistol Championship at Camp Perry, Ohio after a seventeen-year hiatus. This year we had six members, vice four in 2007. This enabled us to field two teams, a four-man team and a two-man team. Eric Graves, John Hollingshead, Steve Peters and Paul Striffler formed an Expert team in the Local Club category; Dennis Walls and Jack Walsh were a Sharpshooter team in the first time ever two-man team Open category.



Before I go into the results of our individual and team efforts I need to explain a little about Camp Perry and the course of fire for the pistol phase of the National Championships. I know I have done this a couple of times before, however we keep getting new members who are not familiar with what goes on at Perry. For those who are interested just read on below, for those of you who are up to speed just skip the below five paragraphs.

The National Rifle Association (NRA) and Civilian Marksmanship Program (CMP) National Championship Matches at Camp Perry start with seven days of pistol matches: followed by smallbore rifle shooting, service rifle matches, high power rifle matches, and finally long range (600 to 1,000 yards) rifle matches. Camp Perry is an Ohio National Guard Base on the southwest shore of Lake Erie next to the town of Port Clinton between Toledo and Sandusky. The pistol phase starts with in-processing Sunday at the base armory where you receive a welcome packet, an official program, and register for the optional CMP Small Arms Firing School (SAFS). Monday morning the U.S. Army Marksmanship Unit (USAMU) conducts the SAFS class. In the afternoon coaching is provided by the military services using rack grade Beretta M9s. The M9s are again used in a 30 round Excellence in Competition (EIC) match Tuesday morning. This match provides an opportunity for competitors who have no points towards the attainment of the U.S. Distinguished Pistol Shot Badge to earn four points. More on the CMP EIC matches when we get to Sunday.

Competitive bullseye pistol shooting starts on Tuesday afternoon with the Harry Reeves Memorial Revolver match in the morning. To shoot this match you must use a center fire revolver with any sights. The course of fire is the National Match Course (NMC): 10 rounds of slow fire at 50 yds, two 5 round strings of timed fire (20 secs. per string) at 25 yds, and two 5 round strings of rapid fire (10 secs. per string) at 25 yds. Following the Harry Reeves Memorial Match a NRA Distinguished Revolver match is conducted. The course of fire is also the NMC and only stock .38 pistols with iron sights and 158-grain

### AAF&G BULL ROAST 2008

For yet a third year we were blessed with pleasant weather for the bull roast. Pleasant, that is, if you like it somewhat hot, but it was September in Maryland, so we expected nothing less. But that's about all we can complain about this year.



The food was, as usual, excellent and to my knowledge no one went away hungry. If anyone did, it was their own fault. Kathy and Mike Anderson did their usual excellent job of obtaining the food, and scheduling

and organizing the prep and the cooking. Our crew of 24 volunteers was prompt, efficient, and ready to tackle anything to make the bull roast the outstanding success it was. In fact, without the volunteers, there could have been no bull roast.

Thanks, in part, to the fact that it was a sanctioned weekend and coupled with the scheduling of the 6<sup>th</sup> Annual Ernie Clarke Memorial Club Championship for the same weekend, the bull roast enjoyed a record turnout with 71 members and 61 guests for a total of 132 attendees gathered under the large tent provided and erected as a precaution against excess sun or rain courtesy of Richard Dein.

lead ammunition can be fired. The top ten percent of the shooters gain points towards the coveted NRA Distinguished Revolver Badge. A total of 30 points is required to win this award.

On Wednesday all competitors fire the NRA Preliminary Pistol Championship. This is a much-needed opportunity to get a feel for the Camp Perry range and checkout the guns that will be used in the National Championship. The course of fire is a 900 aggregate consisting of a NMC fired with each of the three guns used in the 2700 Championship grand aggregate. That is the .22, center fire and .45 pistols. Most competitors will shoot the .45 for both the center fire and .45 phases of the 2700.

The National Pistol Championship 2700 starts Thursday with the .22 pistol championship. The centerfire pistol championship follows on Friday, and the .45 pistol championship on Saturday. Each of the three pistols is fired in a 900 aggregate which consists of ninety rounds fired as follows: 20 round slow fire match, 30 round NMC, 20 round timed fire match and a 20 round rapid fire match (see paragraph four for the strings, distances and times). Awards are provided to the top shooters in each match, the 900 aggregates, and the total 2700 championship grand aggregate by NRA classification, category (civilian, police, or service), and overall winner. NRA classifications are gained by demonstrating an ability to shoot above a certain percentage in NRA sanctioned tournaments. The classifications for outdoor conventional pistol are: High Master 97%, Master 95%, Expert 90%, Sharpshooter 85% and Marksman below 85%. The team matches are conducted immediately after each pistol aggregate is completed. The pistol fired that day is what each team shoots and the course of fire is the NMC. Awards for team matches are provided across team classifications, categories, and overall winners.

The CMP National Trophy Pistol Matches fired with milspec service 1911s or M9 pistols with open sights are held on Sunday morning. The National Trophy Pistol Matches are the nation's national championship in service pistol shooting. These matches have a long tradition that dates back to 1891 when the Distinguished Pistol Shot Badge was established by the Department of War and even earlier to when military pistol competitions first began in this country. The first relays are for the President's Pistol Match, or as more commonly know, the President's One Hundred. The course of fire is 40 rounds made up of 10 rounds of slow fire at 50 yards and the NMC. Thus, 20 rounds of slow fire are fired and 10 rounds each of timed and rapid fire. The top 100 shooters earn the distinction of wearing the Presidents One Hundred patch or badge. The second set of relays is for the National Trophy Individual Pistol Match. This is an EIC match where the top ten percent of shooters earns ten points towards the attainment of the U. S. Distinguished Pistol Shot Badge.

Thirty points are required to earn the badge. The last match of the week is the National Trophy Pistol Team Match. This match consists of four man teams firing the service pistol in the 30 round NMC. The teams must have one shooting member that has never fired in a National Trophy Pistol Team Match.

Hopefully the overview was painless. It was greatly reduced from previous publications, however if you would like the complete perspective let me know and I will e-mail you a copy. Now on to the accomplishments of our AAF&G shooters – and there were many. John Hollingshead our Master class shooter, though not having much of an opportunity to shoot prior to the Nationals, did quite well. At the Nationals the top 10 percent of each classification for each match receive awards. John received awards for 3<sup>rd</sup> place in the .22 rapid fire match, 10<sup>th</sup> place in the center fire timed fire match, and 4<sup>th</sup> in the .45 rapid fire match. This is quite an accomplishment competing against 102 Master level shooters. His most noteworthy awards were received in the CMP service pistol matches. Firing his accurized Berretta Model 92 (the civilian equivalent to the M9) John qualified in the prestigious Presidents 100, and in the EIC match he finished first of 314 non-distinguished competitors earning 10 points towards attaining designation as a U. S. Distinguished Pistol Shot. Competing for the first time at the National Championship Steve Peters, firing in the Sharpshooter class, did extremely well. He finished 3<sup>rd</sup> in the centerfire rapid fire match, 10<sup>th</sup> in the .45 NMC, and 6<sup>th</sup> of 100 civilian Sharpshooter competitors in the center fire championship. Steve's accomplishments as a first time shooter at Camp Perry were truly exceptional. The AAF&G teams gave their all, however fell short in their categories. The two-man team competed with four other teams of higher classification in that there were not enough teams to break out in categories. The four-man Expert Local club team had a few bright spots though finishing fourth out of four teams in the overall championship. In the .45 team match AAF&G finished second of four teams only 37 points off of first place. The last place category championship finish was 47 points out of 3<sup>rd</sup> place and better than ten other Expert teams in different categories. All in all it was a great time at Camp Perry. Hopefully more AAF&G competitors can join us in 2009.

## MARYLAND STATE SHOOTER QUALIFICATION SESSIONS

AAF&G held its first 2008 Maryland State Shooter Qualification for shotgun, muzzleloading rifle and bow from 10am to 3pm on Friday, August 29<sup>th</sup> and will hold another one also from 10am to 3pm on Friday, September 19<sup>th</sup> at the Eccles (High Power) Rifle Range. Meeting the requirements of the qualification will result in issuance of a 2008/2009 state shooter qualification card. The Bowhunting Qualification is conducted on the AAF&G archery range but potential and aspiring bowhunters should check in with qualification staff at the Eccles Range first.

The Maryland State Shooter Qualification card is a necessary adjunct to the Maryland Hunting License for many organized hunts on private property and almost all controlled hunts on the many federally controlled properties in Maryland.

The requirements are straightforward: Shotgun: 3 out of 5 shots in a 9-inch circle at 40 yards; Muzzleloading Rifle: 2 out of 3 shots in a 9-inch circle at 40 yards; and Bow: 3 out of 5 in vitals of a 3D deer and unmarked distances under 30 yards. Note that the modern rifle and handgun qualifications have been discontinued by DNR due to a lack of hunts requiring the shooter qualification card in those counties that allow deer hunting with rifles and handguns.

Shooter qualifications are conducted at many other locations throughout Maryland, the other two in Anne Arundel County being Stoney Creek and Meade Natural Heritage. For a schedule of qualifications to be held at those locations and for a complete listing of locations where shooter qualifications are being conducted elsewhere in Maryland this year, go to: <http://www.dnr.state.md.us/wildlife/shootqual.html>

As is our wont, the HPRR will not be devoted exclusively to these qualification efforts and AAF&G members will not be turned away if they come for casual shooting on these dates.
